

# Underage Drinking in Michigan

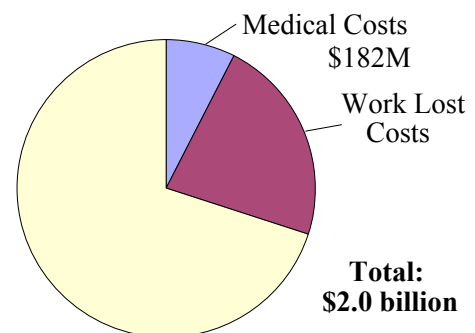
## *The Facts*

Tragic health, social and economic problems result from the use of alcohol by youth. Underage drinking is a causal factor in a host of serious problems, including homicide, suicide, traumatic injury, drowning, burns, violent and property crime, high risk sex, fetal alcohol syndrome, alcohol poisoning, and need for treatment for alcohol abuse and dependence.

### *Problems and Costs Associated with Underage Drinking in Michigan*

Underage drinking cost the citizens of Michigan \$2.0 billion in 2005. These costs include medical care, work loss, and pain and suffering associated with the multiple problems resulting from the use of alcohol by youth.<sup>1</sup> This translates to a cost of \$1,988 per year for each youth in the State. Michigan ranks 34<sup>th</sup> highest among the 50 states for the cost per youth of underage drinking. Excluding pain and suffering from these costs, the direct costs of underage drinking incurred through medical care and loss of work cost Michigan \$641 million each year.

Youth violence and traffic crashes attributable to alcohol use by underage youth in Michigan represent the largest costs for the State. However, a host of other problems contribute substantially to the overall cost. Among teen mothers, fetal alcohol syndrome (FAS) alone costs Michigan \$30.1 million.

Young people who begin drinking before age 15 are four times more likely to develop alcohol dependence and are two and a half times more

likely to become abusers of alcohol than those who begin drinking at age 21.<sup>2</sup> In 2004, 2,720 youth 12- 20 years old were admitted for alcohol treatment in Michigan, accounting for 10% of all treatment admissions for alcohol abuse in the State.<sup>3</sup>

## ***Alcohol Consumption by Youth in Michigan***

Underage drinking is widespread in Michigan. Approximately 409,000 underage youth in Michigan drink each year. In 2005, according to self-reports by Michigan students in grades 9-12:<sup>4</sup>

- 73% had at least one drink of alcohol on one or more days during their life.
- 23% had their first drink of alcohol, other than a few sips, before age 13.
- 38% had at least one drink of alcohol on one or more occasion in the past 30 days.
- 23% had five or more drinks of alcohol in a row (i.e. binge drinking) in the past 30 days.
- 4% had at least one drink of alcohol on school property on one or more of the past 30 days.

In 2005, underage drinkers consumed 14.5% of all alcohol sold in Michigan, totaling \$605 million in sales. These sales provided profits of \$293 million to the alcohol industry.<sup>1</sup>

## ***Federal Resources Available for Combating Underage Drinking in Michigan***

Michigan received \$360,000 in 2005 to address underage drinking for the Enforcing Underage Drinking Laws Program administered by the Office of Juvenile Justice and Delinquency Prevention. Additional funds available for substance abuse prevention and treatment in 2005 in Michigan include:

- \$57.7 million through Substance Abuse Prevention and Treatment Block Grants administered by the Substance Abuse and Mental Health Administration (SAMHSA).
- \$5 million through Substance Abuse Prevention Discretionary Funding administered by SAMHSA.
- \$5.4 million through Substance Abuse Treatment Discretionary Funding administered by SAMHSA.<sup>5</sup>
- \$16.2 million through the Safe and Drug-Free Schools and Communities State Grants Program of the U.S. Department of Education.<sup>6</sup>
